



TERMS OF USE – Image Database of Plant Disease Symptoms (PDDB)

1. General

This term provides the rules for using the image database of plant disease symptoms available at: <https://www.digipathos-rep.cnptia.embrapa.br/>.

Embrapa Agricultural Informatics maintains the Image Database of Plant Disease Symptoms.

For the purposes of these terms, any natural or legal person who freely accesses this system via Internet is called a User.

2. Purposes of PDDB

PDDB was created to serve as a reference for the development of methods for automatic detection and recognition of plant diseases. All images were labeled by experienced plant pathologies, thus providing reliable data for algorithm training.

3. Rights and Responsibilities

3.1 Embrapa:

- Are holders of intellectual property rights relating to the content in the database (images and labels), as established by the Copyright Law No. 9610 of 19/02/1998 of the Brazilian Federal Government and related.
- Are not responsible for any interruptions or failures of access due to technical problems.

The owners have the right, at any time, to change or discontinue PDDB, including, without limitation, the content and hours of availability, without notice (except as and when required by law or as stated in these Terms of Use).

The owners disclaim to any liability, judicial or extrajudicial, on any damage, loss and / or damage arising from the use of PDDB.



3.2 User
